PLEASE NOTE: The application form will still be open a few minutes after the deadline to allow for possible technical challenges, but any applications received after the official deadline on April 5th, CANNOT be guaranteed consideration by the jury.

We strongly encourage you to read about the details of the residency programme and how to apply on our <u>webpage</u>, where you will also find a <u>FAQ</u> page about the residency centre, our partners and our application process.

Any application that is not in accordance with the following requirements will be omitted:

- Application must be in English.
- You/your collective must have signed a minimum of two completed artistic professional productions, not including the project you are applying with.
- Applications involving a single person are not accepted, however solo works may be considered if they are rooted in a collaborative proces.
- It is necessary to be available at least ten weeks, in timespans of minimum 2 weeks. These ten weeks must be in the period between 1 August 2024 to 30 June 2025, with a duration of 2-4 weeks per residency.

By submitting an application you agree to letting Bora Bora Residency Centre keep and store the information you provide in this application for the purpose of contacting you regarding Bora Bora residencies.

All documents and personal information will be deleted one year after the deadline, April 5th 2025. This accounts for the applications not admitted to further residency prospects. For the admitted applicants documents and personal information will be deleted one year after the collaboration has ended.

All information including video content will only be used for internal purposes of the selection process by staff in Bora Bora and the artistic advisory board of Bora Bora, consisting of Samme Raeymaekers (BE), artistic director of Dansens Hus in Oslo and Sigrid Aakvik (NO), Head of the Nordic agency Art & About in Aarhus.

Applications will be shortlisted by producers in Bora Bora Residency Centre and further selections are made by the artistic advisory council of Bora Bora.

Due to Danish funding at least two out of the five selected projects must be from Danish artists or artists based in Denmark.

Answers to the applications will be given to applicants by 17 May 2024.
